Dear Algy:

We have received an Order reassigning the Activision case from Judge Vukasian to Judge Charles A. Legge. Judge Legge is a new district court judge in the Northern District of California. The reassignment is apparently part of the effort to create a docket for him. Tom Rosch, our local associate, informs us that Judge Legge is an excellent and experienced civil litigator.
