Dear Art:

Please find enclosed 82 underwater color items. They cover the following types of fish: rays, moray eel, lizard fish, needlefish, snook, blenny and parrot fishes. Besides these fish I have also enclosed a generous portion of other Florida reef fishes.

For the past two months I have been shooting color on my own since I heard NGS was doing a revised book of fishes.

Inasmuch as I have considerable time and expense involved in gathering this material, I would like to receive a presentation holding fee in the amount of \$200 from NG. This will be above the amount you finally end up paying if you decide to use any material from this batch or from my catalog.

As to terms of sale, my usual procedure is to sell one-time reproduction rights for inside book use. If the book goes into additional printings there is no added charge. If book of fishes goes into a revised or second edition and material is used again, there is an added fee, usually 50%. I don't have any worries as to what you folks will end up paying, but I would like to bring the above point up ahead of time.

I've enclosed an outline of a suggested photo-story about sharks together with five layouts for the board of review's consideration.

As you know, every year the piercing cry of "Shark! Shark!" resounds along our coastlines and sends thousands of bathers tumbling to shore. Despite the fact that the shark takes a comparatively small bite of the death statistics (there have been some 90 authenticated attacks since 1900), the very name shark still manages to strike fear in the hearts of swimmers and skin divers.

The point of view of the first part of the suggested photo-story is to strip away the layers of mythology and misconceptions that have accumulated about the shark. The second half of the story would deal with the various projects and studies to better understand the misunderstood shark.

I would like to add that my recent acquisition of improved underwater photographic gear now allows me to shoot sequence (Nikon 250-exposure rig) in either Kodachrome or H.S. Ektachrome.

I have recently made an interesting alteration on one of my Rolleiflex 150-exposure magazines where it will take 30 to 40 feet of film and yield 250 to 350 exposures (preferable on Kodachrome II).

By using my synch with strobe and utilizing special underwater lenses, I will be able to get 1:½ to 1:1 ratio closeups on color film.

You can probably realize the beautiful color quality possible on Kodachrome II.

I can get plenty of Anscochrome in 35mm. 100' loads, but I would prefer to use Kodachrome II. Is it possible for me to secure two 100' rolls of 35mm. Kodachrome II from NGS? Naturally, I want to pay for this material. Please advise.

Incidentally, does your equipment department need any underwater light meter? I have a new Leica meter with plastic case available.

Jerry,

By now you know the good news that the Editor has approved the assignment on Key Largo for you. I have received your list of expenses and gone over them. In view of the unusual problems of working underwater I feel this is reasonable even though it adds up to over a hundred dollars a day.

We will pay a premium of double the normal page rate because of the difficulty of the job. This would amount to \$200.00 a page or \$100.00 minimum per picture used in color. Considering a minimum size of 8 color pages we would guarantee you \$1,600.00 for the job. I would estimate that a successful job would occupy no less than 16 color pages, and as high as 24.

All pictures used in the story plus a few for file selects would become the property of the National Geographic Magazine. After publication in the Magazine all rights on those pictures not held by us would be yours to sell.

Insofar as The Society is concerned, you will undertake this assignment as a free lance agent and independent contractor, and not in any sense of the word as a person employed by the Society, directly or indirectly. Further, acceptance of financial and other considerations outlined in this letter shall constitute an absolute release to the National Geographic Society of all responsibility for personal injury, and/or death, which may arise out of or result from this assignment.

Enclosed is a check for \$1,500.00 as an advance towards expenses on the assignment. Please keep records for our Auditing Division. The enclosed daily expense slips are used by the staff, and do have the advantage of providing a system. Use them if you like. As this money is used notify us and we will try to guess how much more, if any, will be needed within reason to produce a top story. If you have any questions on large expenses that you are in doubt about call me and I will advise you.

Your sketches on the potential pictures for the story make very good sense. As you know from our conversations the key picture will be a superwide shot. This may be two VeriWide shots side-by-side or even three or four. I would like to be there to work with you on it, but I'm not counting on it.

The night shot with the lanterns lends itself to a dramatic picture, but it has to be more than just the lantern and man. In other words, it must be obvious that it is part of a reef story and not in a pool.

The brain coral looks promising.

The sled picture is excellent. It indicates possibilities for recreational use of the area. In this same category would be the picture of the diver using your Rollei housing with the ring light on the front.

For a model be on the lookout for a full-breasted mermaid.

Let's plan to do a spread with 8 to 12 different types of coral that are most common or most interesting. If you do not know which to select let me know and I will talk to a coral expert and make suggestions. This would be in the nature of a catalogue of coral. Those represented in other large pictures in the series should be left from this collection.

Try getting on top of one of the lighthouses and shooting down into the water. This is just a wild idea, but you might try a Panon or wide angle that would cover from the horizon (with a freighter moving across a sunset or sunrise) to the base of the light scaffold looking straight down onto a shallow reef. If you look down into the water (calm night) from this perch would you be able to see a model lighted by a flash or torch underwater? If so, this would make quite a shot. Perhaps having a small boat in the middleground and a diver on the bottom lighted with flash would be successful. This may all be impossible. Even if the diver were only 5 feet below the effect would be there.

If there is anything to be shown do not hesitate to rent a plane for an aerial of the reef.

I'm going to see a park service man here who is well-informed about this park and will pass on any ideas that come from him.

I'll try to answer your questions. We cannot restrict use of your files, but would expect that you not produce a story on the reefs for another magazine. *(right away)*

Mr. Brookfield knows of a wreck or two in this area that might spice up the photographic coverage a bit. If there are any known wrecks in the area be sure to get coverage.

I agree it would be best to rent a compressor.

Regarding a model wouldn't it be easier, cheaper and safer to hire an assistant than to pay a daily rate for a model. This would give you an assistant and diving buddy as well as a model. You might look into the possibility.

If this letter raises any questions or leaves any of yours unanswered don't hesitate to ask me.

Please let me see your film as you go, rather than hold it all until the end. Let me know what film or equipment you might need that we can provide. As soon as the 120 size High-speed Ektachrome is available we will try to get it to you.

I feel that for the best balanced story a photo essay on the entire lab might be better than just photo coverage on any particular NGS grand which might be in effect.

My layout gives just a slight glimpse of the activity around the lab. I feel the most important and best photos should be made at sea on the various expeditions which are slated for next year.

My proposed photo essay would be broken down as follows:

- 50% photos of research at sea
- 20% photos of research at lab proper
- 10% photos of miscellaneous subjects
- 20% photos of experimental and off-beat activities

As you can see from the layout, I have only given you enough to show that I can still handle a camera without a housing around it.

If you can stir up enough interest from Jim Godbold and Herb Wilburn, I certainly would like to do another piece for NGS.

I would appreciate your comments on the layout.



RC-10 (lizardfish) this one was marked in your catalog as RC-11 but I think that number belongs to the coral below it.


RA-18 (tiger shark)

I would like to deliver of myself a few comments regarding the Society's proposed new or revised Book of Fishes. I am sure that the people in charge of this project realize that there's a different climate in the book publishing field now than there was 7-10 years ago.

Some time ago NGS was the only producer of nature and educational books. Now there are several competent publishers in this field who are doing a pretty fair job in their production and selling, viz., Life Books and Chanticleer Press, etc. In short, NG books doesn't have the market cornered as in the past.

This does not mean your proposed fish book will not sell, but only that there are other volumes out that your finished product will be compared against, and in a highly competitive market there will be many occasions where you are going to run a poor second and lose sales.

It is for this reason that I feel the Society cannot afford to produce another bound volume of old Geographic articles, but must come out with a tastefully done, informative and educational Book of Fishes.

I am sure that with your budget restrictions on this project that you will have to forego doing a completely new version of the book and settle for just a good face lifting. There is nothing wrong with this at all, in fact, it will probably be an improvement and a step in the right direction. The important thing is that you understand what was wrong with previous versions of the book and what can be done to correct it.

At one time I had a bunch of suggestions as to what could be done to revamp the book. Unfortunately, time is running short and I will probably be diving in Fort Lauderdale for Naval Ordnance Testing Lab.

Thanks for your letter and check of July 18th.

First of all, I would like to explain why I had to get a \$200 presentation fee for the 80-odd color transparencies which were sent to NGS.

The above-mentioned material is the result of about 12 days of photo-diving done on speculation for the NGS FISH BOOK. You may recall, even when this book was in the embryonic stages no one was in the least bit oriented on what material would be necessary to round out this proposed volume. I took it upon myself to produce these photos at my own time and expense without any assignment or guarantees from the magazine. For the record, my average expenses per day for mileage, boat, motor rental, compressed air, film and processing came to about \$65 to \$75 a day.

As you can surmise, underwater photography is a very expensive proposition, and there aren't any really large markets for what I produce. For these reasons I believe that my request for a presentation fee is not out of line, even though other photographers and agencies are able to work on a different basis. It was for this very reason of not getting editorial understanding and an advance that I withdrew my material from the LIFE BOOK OF FISHES.

In answer to your request of deducting the \$200 fee from any purchase you may make for your FISH BOOK, yes, please feel free to do so.

Incidentally, I have enclosed some additional material for your FISH BOOK: Items M-22 & M-23 are Giant Sea Bass or Jewfish; J-28 is a Hawkfish; and J-3 is a young Moray eel.





Briefly, what I had in mind was a continuation of where I left off on the reef story. That is, a closer look at the more colorful creatures that inhabit the coral reefs, with emphasis on the very small marine vertebrates and invertebrates. As you know, when people dive on the reefs they completely overlook the smaller forms of marine life.

The acquisition of the latest magazine equipment, including a stronger portrait lens, now permits me to do an extremely effective job. I feel that this work should be done in a very lush marine area, such as the Bahamas, Jamaica or the Pacific.

The results of such work could be used two ways by NGS: 1) Would provide material for at least two stories of marine life and, 2) Provide a quantity of underwater color for future use in a new Book of Fishes or possibly a Geographic version of a BOOK OF THE SEA. I believe the time to start working on such books is now.

I've enclosed 16 2¼ x 3¼ color samples which you can whet the upper echelon with. These are color "dupes" from magazine originals.



I received the color contact sheet #2 (less 1 frame) and contact page negatives C-4 a day or so ago. Unfortunately, they got to me a little late and Life Books was unable to use them. Thanks very much for your efforts. I'm returning them to you so that all of the material can be kept together.

Have you gotten a sample of the wide angle Rollei in yet? I am just about finished with the machine work for my housing that will accept the Mag 150 for the Rollei. I have already invested in a large inventory of special Nikor reels (120) in order to process this film in conventional 3½ gallon photofinishing tanks. In fact, I ran through a test batch of 25 feet regular 120 Anscochrome last Saturday and the procedure and processing worked out perfectly. I was able to load enough color film on the Mag spool to give approximately 125 exposures on color film. This is equal to about 10 conventional Rollei loads. Have you heard anything about the HS Ektachrome you ordered?

At the present time I am perfecting a system to enable me to take extreme close-ups underwater with conventional illumination and with ultra-violet light. If either or both systems work I hope to be able to present NGS with some very unusual photographs in the underwater field. The ultra-violet florescence method requires photo-diving at dusk and into the night. This type of photography would also be ideal to provide illustrations for the marine invertebrate project that the University of Miami Marine Laboratory is now working on with the aid of the National Geographic Society. All of this close-up equipment will naturally work with my Mag 150 rig.

Do you think that I can get an additional \$400 advance over the original \$1600 guarantee which I received last year? I have run into additional expenses getting this equipment out and would appreciate it if you could check into this for me. Incidentally, NGS is due \$78 refund from me on some underwater lanterns which it paid for and were returned to the manufacturer because of defects.

Do you think that you will get down to Miami with Bill Garrett for the ASMP conference?





Even though I have just returned from vacation, numerous stories have kept me from doing as much on Key Largo as I would have liked. The following are my first reactions based on going through all of the new material very quickly.

Your surface shots are very poor and not at all up to your underwater pictures. I really feel we can and must do much better.

The seven-shot panorama is quite spectacular. Please don't blast off in uncontrolled flight, but I think you can do better. That is enough sad news for now. Before I do anything further I want to make up a tentative dummy and look at an outline of the manuscript. Since it is not possible to even schedule the story for several months, there is no occasion to be upset. A very few specific pictures will certainly round out what is a very thorough basic coverage. Let me see your file of color and I will make selects. As soon as I am able to put together a rough beginning dummy, I will get approval for at least partial payment for your work.

Since you probably want specific comments on why I am not happy with your surface coverage, I will offer the following:

The many surface shots which should have been bright, light and colorful are made on overcast days with Anscochrome. Your over-under pictures are satisfactory but I really think a little imagination and hard work would make this a spectacular and important picture for the coverage. Regardless of the reason or the problems involved, none of the shipwreck pictures are especially interesting.

Though I am not completely aware of the problems of underwater photography, I am completely in sympathy with them, especially since you had the cunningly good judgment to allow me to shoot a roll myself. It was so lousy that I hesitate to be critical of anything which is made by other people if it is sharp and has any semblance of composition. Nevertheless, from the beginning both you and I have known that we were not shooting for just another underwater story but for the best that we could do.

RE: KEY LARGO ASSIGNMENT

On July 27 we received a letter (addressed to Bill Garrett) from Jerry Greenberg regarding expenses on this assignment. Mr. Greenberg states that, in addition to the \$1500 advance by the Society, he has spent \$1100 of his personal funds. Shortly before receiving the letter, Mr. Greenberg phoned and talked with me about his expenses as well as his production to date. Greenberg stated that expenses were running between \$650 and 750 a week. The compressor which he has been renting, authorized in Mr. Garrett's letter of June 24, cost \$8 per day. In addition to his routine expenses, a check of Greenberg's day to day accounting indicates that more than \$500 has been spent for special equipment. If the cost of this equipment is to be charged to the Society, the equipment must be considered the property of the Society. Mr. Greenberg, therefore, should be instructed to send to us all equipment and supplies, either furnished or paid for by the Society and still in his possession, upon completion of the assignment.

In a letter received July 28 (once again addressed to Bill Garrett) Greenberg estimates that it will take two weeks to complete the assignment.

Based on this estimation of time at the weekly rate indicated, Mr. Greenberg will need an additional expense advance of \$2400.

Greenberg's pictures are good. He is an excellent technician and even though expenses are higher than perhaps was anticipated, I think that we should see the assignment through to completion. I have prepared a request for payment (attached) for your signature.

Try for the three shot panorama and we will let the engravers worry about blending the edges if the picture is good.

Thanks for the written assignment and expense check. Your letter was very complete and left very few questions for me to ask.

I am keeping complete records on expenses. I would appreciate it if you would include some expense slips as used by your staff.

I have already purchased yellow diving suits, underwater lanterns, etc. and have constructed a special underwater tripod with weighted platform. The case for the Verivide is completed and I will test it out this week. I have also adapted one of my Leica housings to take a 21mm. f4 lens which I will use to supplement the Verivide.

Thanks for going over the sketches. It was a real help. Would it be possible to send me several "stats" of each illustration? They would be useful as a guide for my models. Incidentally, the models I will use will also double as diving assistants. I am not going to use any professional photographic models.

I have ruled out the night diving shot as it would all have to be flashed in anyway. I will work on a twilight diving series. Good idea about the different varieties of coral. Besides photographing these growths, I also intend to pin-point them on a chart so they can be cataloged (see illustration).

Your top-side picture suggestions are along the same lines I was thinking of and will be followed through. I already have a metal wreck lined up but will also check with Mr. Brookfield.

I hope to make two trips out this week to check out equipment and models. I hope to officially start on the story July 1. Can you get down here some time in mid-July?

I have enclosed six 11 x 14 Type C enlargements from 35mm. via Internegative. There is slight color variations to give you an example of what can be done.

All I need at the present time are about 3-4 dozen 36 exposure rolls of H.S. Ektachrome.

By now you know the good news that the Editor has approved the assignment on Key Largo for you. I have received your list of expenses and gone over them. In view of the unusual problems of working underwater I feel this is reasonable even though it adds up to over a hundred dollars a day.

We will pay a premium of double the normal page rate because of the difficulty of the job. This would amount to \$200.00 a page or \$100.00 minimum per picture used in color. Considering a minimum size of 8 color pages we would guarantee you \$1,600.00 for the job. I would estimate that a successful job would occupy no less than 16 color pages, and as high as 24.

All pictures used in the story plus a few for file selects would become the property of the National Geographic Magazine. After publication in the Magazine all rights on those pictures not held by us would be yours to sell.

Insofar as The Society is concerned, you will undertake this assignment as a free lance agent and independent contractor, and not in any sense of the word as a person employed by the Society, directly or indirectly. Further, acceptance of financial and other considerations outlined in this letter shall constitute an absolute release to the National Geographic Society of all responsibility for personal injury, and/or death, which may arise out of or result from this assignment.

Enclosed is a check for \$1,500.00 as an advance towards expenses on the assignment. Please keep records for our Auditing Division. The enclosed daily expense slips are used by the staff, and do have the advantage of providing a system. Use them if you like. As this money is used notify us and we will try to guess how much more, if any, will be needed within reason to produce a top story. If you have any questions on large expenses that you are in doubt about call me and I will advise you.

Your sketches on the potential pictures for the story make very good sense. As you know from our conversations the key picture will be a superwide shot. This may be two VeriWide shots side-by-side or even three or four. I would like to be there to work with you on it, but I'm not counting on it.

The night shot with the lanterns lends itself to a dramatic picture, but it has to be more than just the lantern and man. In other words, it must be obvious that it is part of a reef story and not in a pool.

The brain coral looks promising.

The sled picture is excellent. It indicates possibilities for recreational use of the area. In this same category would be the picture of the diver using your Rollei housing with the ring light on the front.

For a model be on the lookout for a full-breasted mermaid.

Let's plan to do a spread with 8 to 12 different types of coral that are most common or most interesting. If you do not know which to select let me know and I will talk to a coral expert and make suggestions. This would be in the nature of a catalogue of coral. Those represented in other large pictures in the series should be left from this collection.

Try getting on top of one of the lighthouses and shooting down into the water. This is just a wild idea, but you might try a Panon or wide angle that would cover from the horizon (with a freighter moving across a sunset or sunrise) to the base of the light scaffold looking straight down onto a shallow reef. If you look down into the water (calm night) from this perch would you be able to see a model lighted by a flash or torch underwater? If so, this would make quite a shot. Perhaps having a small boat in the middleground and a diver on the bottom lighted with flash would be successful. This may all be impossible. Even if the diver were only 5 feet below the effect would be there.

If there is anything to be shown do not hesitate to rent a plane for an aerial of the reef.

I'm going to see a park service man here who is well-informed about this park, and will pass on any ideas that come from him.

I'll try to answer your questions. We cannot restrict use of your files, but would expect that you not produce a story on the reefs for another magazine. *(right away)*

Mr. Brookfield knows of a wreck or two in this area that might spice up the photographic coverage a bit. If there are any known wrecks in the area be sure to get coverage.

I agree it would be best to rent a compressor.

Regarding a model wouldn't it be easier, cheaper and safer to hire an assistant than to pay a daily rate for a model. This would give you an assistant and diving buddy as well as a model. You might look into the possibility.

If this letter raises any questions or leaves any of yours unanswered don't hesitate to ask me.

Please let me see your film as you go, rather than hold it all until the end. Let me know what film or equipment you might need that we can provide. As soon as the 120 size High-speed Ektachrome is available we will try to get it to you.

Thanks for your phone call of Friday regarding the Reef Diving Essay. I appreciate your faith in me and will do everything in my power to give the magazine the finest underwater illustrations it is humanly possible to produce.

I have enclosed an expense schedule which will give you an idea of what is involved in a day's work. I figure that it would cost about \$110.00-125.00 a day for diving or active stand by. This would apply only to days actively involved on the story. Naturally, the days when we don't dive due to bad weather, there are no charges involved. I figure we could dive about 3-4 days in a row. The price of \$110.00-\$125.00 a day also pays for one model, the price of diving air or a rented compressor is not included in this price. I have listed a complete schedule of expenses so you can see how the final figure is broken down.

At this point I would like to go over two items for you. 1) If a magazine, say in the next month or so, wants to use some illustrations from my own photo library for an underwater article, what are my obligations to National Geographic? Would there be any conflict? 2) As you mentioned on the phone, the magazine would retain possession of all of the originals which were used in the story. I also understand that any material not used would be returned to me for my own use. This is agreeable with me. I would like to work out an understanding with you in regards as to the re-use of the published material is concerned. I would work out an arrangement where by all requests for this material would be channeled through me. This way I would have some control as to its use in textbooks, encyclopedias, etc. What I want to avoid is a situation where I would be competing against myself. I'm sure, as a working photographer, you can understand my problem and pass on this slight advantage to me. In appreciation of the above consideration I would like to put in your hands my entire photo library for use in the final layout of the forthcoming story. This consists of about 135-35mm. and 37-Rollei contact pages as well as about 200 prime color slides. This is the output of about eight years of photo-diving. ~

I am now working on a housing for the Veriwide and should have it ready in about 7-10 days. As you know this camera takes in an angle of view of 100° (about 80° wet). With it I can do the following: 1) Use it for one shot, 2) Put it on a tripod for a two exposure panorama view which will yield about 160°, 3) Take the first color photographs of a large section of coral reef at night using flash bulbs. The last two ideas would make beautiful goldouts. Later on this week I am going to send you several 8 x 10 Type C prints to give you an idea of the many variations possible in color balance.

I would have written sooner to thank you for your wonderful Southern hospitality, but I have been visiting friends in New York last week.

I had an opportunity yesterday to discuss your 35mm. panorama camera with Luis Marden. He pointed out that through Tom Abercrombie's efforts The Society already has constructed an underwater housing for the Panon, and a color illustration made with this equipment will appear in the April National Geographic. We also had to design a specially curved lucite window, as you have done. I am enclosing a tear sheet of Tom's photograph showing Captain Cousteau's "turtle" being lowered into the sea. As you will see, this was a rather tricky exposure since the upper part of the picture is above the surface.

Since The Society now has the equipment to make panorama underwater shots, I am afraid there would be little interest in backing your 35mm. camera housing. In fact, Luis mentioned we also have been considering building a housing for a 35mm. panorama camera, but our machine shop has been tied up with more pressing jobs. If you should decide to go ahead on your own and develop the 35mm. housing for the Widlux, and it proves satisfactory, then we would be interested in considering purchasing a duplicate model from you. This would save us the cost of experimenting with various designs and free our technicians for other projects. Since you are planning to go out of the manufacturing business, I suspect this idea will not interest you, but I mention it anyway in view of Marden's comments.

I certainly enjoyed seeing your color transparencies of coral reef life. You have some very fine, sharp closeups. At present we

have no story in the works with which your material might fit, but we certainly will keep it in mind. For example, if we should go ahead with an article on the undersea park, then we would want to take a look at your color contact pages.

I turned over to Jim Godbold, our Director of Photography, the pamphlets on the undersea equipment you have been manufacturing. I told him you were planning to close shop when your present supply of equipment has been exhausted, so now is the time to order anything we might need. I understand one camera housing arrived last week for Bates Littlehales. This equipment was purchased by Bates for his personal use and is not The Society's property, as you may know.

I am returning enclosed the black and white panorama print and the two comparison negatives since you probably want this material for your records.

Again, many thanks for the many courtesies extended to me in Miami. I hope we will have an opportunity to get together again before long.

Just a line to say hello and keep you informed on what I've been doing. For the past year I have been working on two underwater photographic items: an underwater electronic flash and various methods of shooting close-ups (six inches away) underwater.

I firmly believe that this new equipment opens up a new source of exciting underwater photographs. It is now possible to photograph all types of brilliantly-colored marine tropical fish in their natural habitat. The electronic flash will enable me to "freeze" motion and get wonderfully sharp transparencies as well as subtle pastel colors in the underwater world brought out by the color temperature of the lamp. The close-up rig has been very successful in photographing the unusual coral and sponge growths.

As you can gather, I'm excited about this equipment and its potential. The electronic unit itself creates an entirely new concept in underwater photographic quality. I therefore would like to seriously reconsider the prospect of my doing a photo series either on marine tropicals in their natural habitat or a comprehensive color photo study of a coral reef in close-up studies.







Sting Ray: Lying buried in the sand. This is how they camouflage themselves and are hard to see by the bather and are often stepped on.

Barracuda: A large pack of barracuda lying motionless in mid-water on the change of tide. They are feeding.

Sea Urchin: The type described by Dr. Smith. Positioned in a white sandy bottom.

Black Tip Shark: Swimming over a patch of coral.

Hammerhead Shark: Photo of a hooked hammerhead taken during collection on Seaquarium boat.

Also: Photo of sting ray in motion. Clearly showing the method in which these creatures propel themselves. Series of pictures showing diver and tiger shark. Shark has been hooked and diver - armed only with a "billy" - attempts to herd shark into collecting boat's well. Taken during a collection expedition of the Seaquarium.
