The position of Commissioner of the U.S. Patent and Trademark Office is extremely important for the advancement of technology in the United States. I am pleased to write this letter in support of Norman J. Latker for that position. I have known Mr. Latker over a period of ten years during which I was involved in technology transfer at a university. A review of his resume does provide some indication of how instrumental he has been in this area. When technology transfer was not in "vogue", Mr. Latker had the foresight to understand its importance for the economy of the nation and from his positions in NIH, DHHS and Commerce worked diligently to get legislation and regulations approved that are cornerstones which have enabled significant technology transfer to occur, especially from universities to industry.

The availability of these early stage venture funds will greatly enhance our ability to build companies around inventions originating at the University of Chicago and the Argonne National Laboratory.

We now have four new companies operating in Illinois. None of them is over a year old and only one has its own CEO but it represents a start. We have many more potential enterprises in the pipeline.

These laws, through the patent system, have promoted greater cooperation with and an increased flow of research dollars from the industrial sector to the universities; have, increasingly, resulted in many new innovative products being brought to the market; and, thus, have increased the competitiveness of the United States in the global economy.

Mr. Latker is keenly attuned to the complexities of the technology transfer function and is dedicated to maintaining a vital and viable U.S. patent system to serve as a catalyst for innovation.

On a more personal note, I have worked with Mr. Latker on university-government-industry relationships and technology management issues since the early 1960's and have found him to be a truly dedicated public servant. He has always been honest and forthright and wholly committed in the discharge of his duties. Because of his unique qualifications, as a patent attorney and long-time public servant, he understands both government and the Patent and Trademark Office and would make an excellent Commissioner.



I'm writing to recommend Mr. Norman Latker for Commissioner of Patents and Trademarks.

Having been registered to practice before the PTO (Patent and Trademark Office) for more than 27 years, I've observed the operation of that Office under a number of Commissioners. It's difficult to find someone who will be effective in this position, because it requires a combination of experience and insights which are rarely encountered in an individual. Present needs of the PTO call for an even more critical blend of qualifications.

Mr. Latker has attributes that convince me he would be <u>quite</u> effective if appointed. This strongly underlines the desirability of a candidate, such as Mr. Latker, having solid training and professional experience relating to this field.

I'm struck by the comprehensive and very appropriate range of relevant government, private sector, legislative, regulatory, information handling and biochemical skills and perspectives which Mr. Latker offers, and I hope you will be too. It seems to me he provides a unique inventory and <u>balance</u> of critically needed attributes which make him the right man for the job as it exists today and as I foresee it for the future. We write to take note of Norman Latker's past record as an outstanding public servant and a person of high moral character.

Mr. Latker served as Patent Counsel to the Department of Health, Education and Welfare when he first recognized that changes in institutional behavior were needed if new drugs were to ultimately reach the public. He developed an Institutional Patent Agreement which facilitated technology transfer by creating a mechanism whereby colleges and universities could more effectively and far more quickly license inventions stemming from federally sponsored research. Heretofore, a significant number of inventions remained on government shelves because there was no inducement to develop them further. In the 1960s DHEW was alone in recognizing the benefit of this mechanism. Mr. Latker worked tirelessly to encourage its use, thereby encouraging technology transfer.

Later, he became architect of P.L. 96-517 which translated his work at DHEW into national patent policy. Many of the helpful university inventions that we see in public use today are there because Norman Latker had the courage and persistence to overcome barriers. P. L. 98-620 followed several years later. This law further facilitated technology transfer and Norman Latker was an important factor in its development.

Before his present position, Norman Latker was Director, Federal Technology Management Policy in the Department of Commerce. It is clear to the college and university community that Norman Latker wants to remove from the innovation process all unnecessary barriers to the marketing of new American products. 

#### Dear Senator Hatch:

I am writing to you again to further emphasize the urgency for your endorsement of Norman J. Latker as Commissioner, United States Patent and Trademark Office. As a patent attorney, inventor, and small business developer I am keenly aware of the critical need to upgrade and automate the procedures of the United States Patent and Trademark Office.

Automation is particularly important with respect to filing foreign patent applications based on U.S. patent applications. The Paris Convention provides for a one year period from the date of filing of the U.S. patent application in which to file the various foreign patent applications in order to take advantage of the provisions of the Paris Convention. Regrettably, it is a frequent problem that the first Office Action from the Examiner in the United States Patent and Trademark Office is not received until this year period has passed. This Office Action is important because it is a good indicator of the scope of patent protection that one can expect to receive. In the absence of this information I generally advise my clients to not file foreign patent applications.

The current fusion discoveries also illustrate the immense value Norman J. Latker will be as the Commissioner of the United States Patent and Trademark Office. He will be able to bring his considerable skills to bear on the handling of the hundreds of patent applications that are going to be filed on this technology. I can not think of any other matter that is more urgent or that could benefit more from the skills of Mr. Latker.

In summary, we <u>must</u> automate the United States Patent and Trademark Office under the expert guidance of Norman J. Latker or hand over the leadership in patent matters to the Europeans and the Japanese in default.
