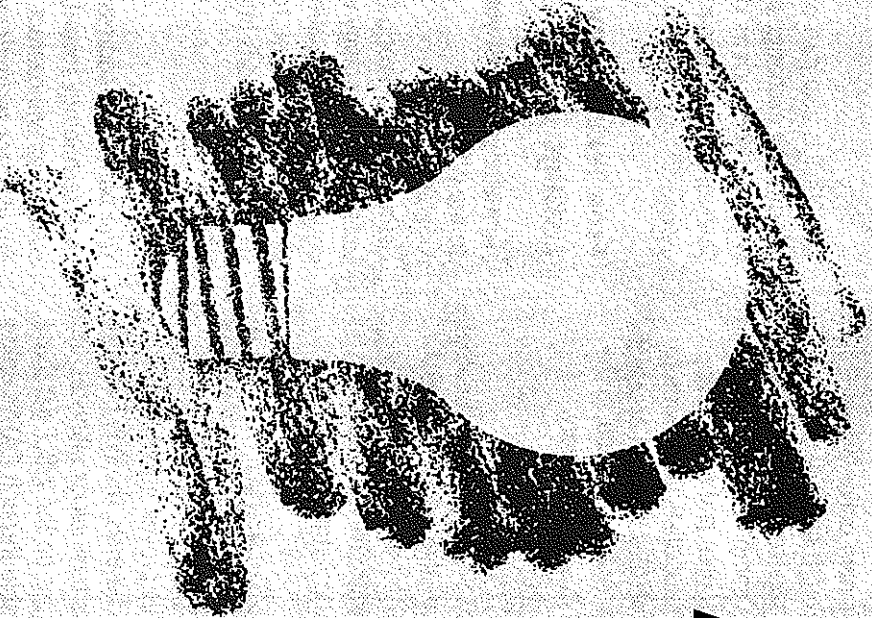

This has been a very exciting time for InfoEd International, Inc.! We are experiencing rapid growth in our products and services and in our staff, and we are going to share all the good news with you at the AUTM San Francisco conference February 19-23.

Technology Transfer™ is being released in the PC format as of February 10, with the MAC format released by the end of February. The differential of just one week is due to the fact that the program features have expanded beyond our original vision thanks to our Beta Testers, who were very thorough in their testing and very clear in stating their needs and concerns.

As a result, Technology Transfer™ is more than a data collection tool; it is a comprehensive management tool. It is our goal to make all your tracking of critical information, data entry and retrieval, as simple and as accessible as possible.

I am relating this to you for two reasons. First, if you have been following our progress on Technology Transfer™, it should be clear to you that InfoEd is not just another software company. We are your advocate. As your needs were relayed to us, they were added to the system. When we heard your concerns, we addressed them. We are a customer-driven organization, building a product for the sole purpose of helping you do your job better through easy and logical data entry, data retrieval, data searching and data reporting.



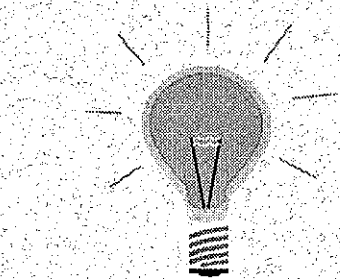

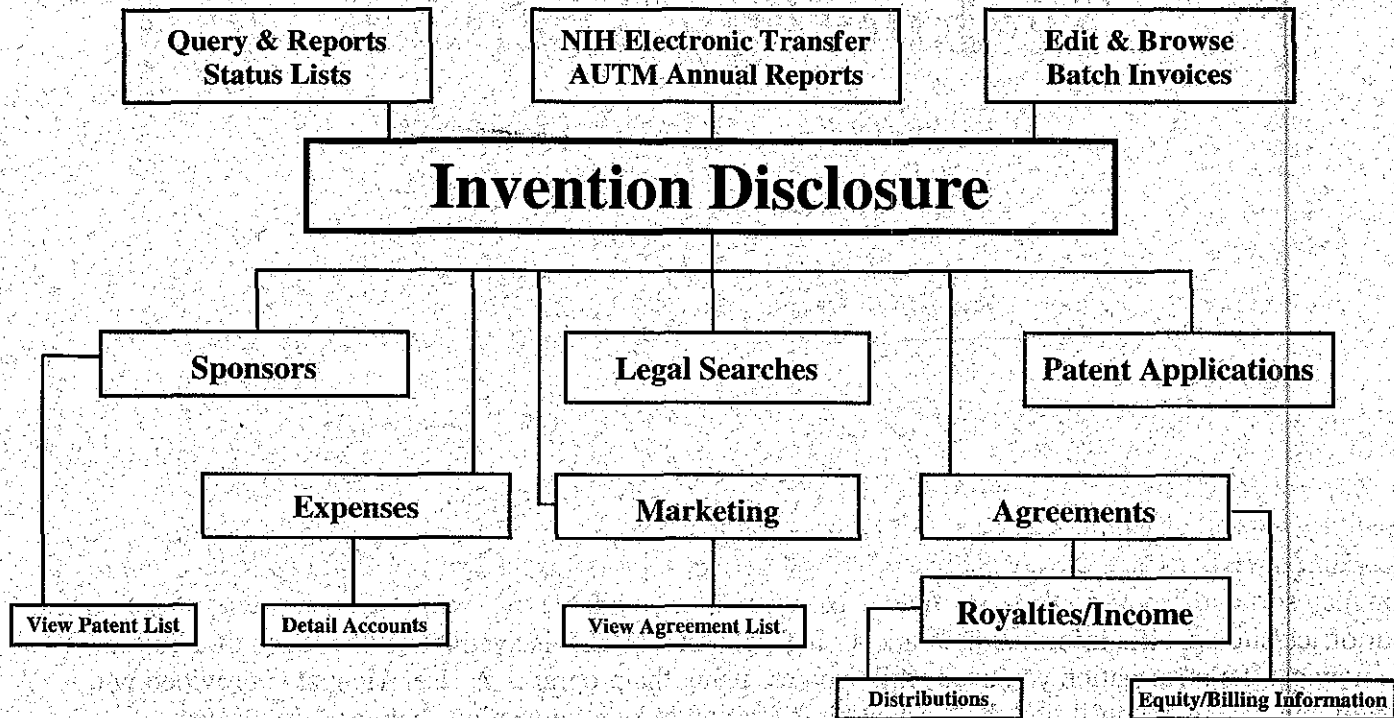

Technology Transfer System



EXPENSES - Through this screen, you may elect to maintain a summarized or detailed accounting of all expenses, incurred and reimbursed in connection with this disclosure. Technology Transfer will keep a running balance and simplify the whole tracking process for you. For quick entry of legal invoices, use the Batch Entry system available in our Edit mode. Invoices may be entered and when items are posted, they will create an expense entry for each Case Number, automatically posting each detail entry correctly.

MARKETING - Never misplace important contact information again! This screen keeps track of who you talked to, when, and where you can reach this contact again - an "on-line" contact resource that is invaluable when you need to reach someone quickly, and includes a free text comment field and six user-defined fields.

AGREEMENTS - No matter what kind of agreement you enter into, you can track the details on this screen. There is a free text area for agreement details. In addition, there is an Agreement Detail screen to track contacts, license equity, and billing information. This gives you the ability to know when to expect what from whom for current receivables and forecasting. To track the royalties and other income, select the Royalty button. In addition, there are six user-defined fields and a free text comment field on both Agreements and Royalties.

ROYALTIES AND OTHER INCOME - Now there is a better way to track royalties and other income generated by each agreement. You may track the purpose for which you received the money, date received as well as posting date, and after subtracting direct expenses, the program will calculate the amount available for distribution. You then have the option of tracking distributions to inventors, departments, and other institutions, with the un-allocated balance calculated and available on screen.

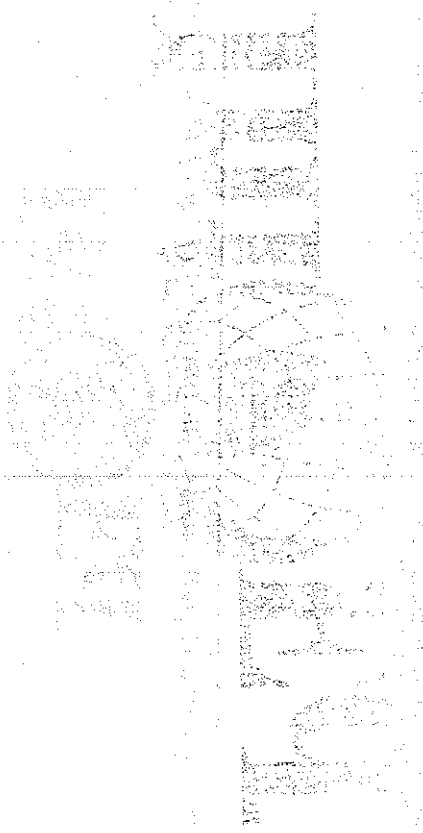
ALL MODULES - As you review the highlights of each module, be aware that in addition to the critical management information fields, all standard information fields required by US Federal Government reporting (**NIH EDISON** and **AUTM**) have been included. This means that the system has electronic reporting capability as well as hard copy generation. Furthermore, on each of the module data entry screens, with the exception of Expenses, there are **six user-defined fields: three standard test fields and three label fields**. You may sort and report on these six fields. Now you have available more capability and flexibility in tracking your office/site-specific information than ever before! And, **HELP** is available at the touch of a button. You can now get the information you need while you are using the program. A User Manual is provided with each system, but we think you'll find the "instant" information to be a tremendous help and time-saver.

INVENTION DISCLOSURE - Through this main information screen you can track all the details pertaining to the original disclosure, including an unlimited number of inventors and office staff, date of public disclosure, assigned rights, and keywords (used for searches as well as bundling technologies). There are three free text areas: disclosure title, a non-confidential description (i.e., precis), and general comments.

SPONSORS - From the sponsor database provided, you may add sponsors as needed and then assign one or more to a specific Invention Disclosure. All sponsor information is tracked, and you may use the user-defined fields and free text comment fields for further pertinent information. While you are in this screen, you may also view the list of Agreements you have on file for this sponsor for this invention disclosure.

LEGAL SEARCHES - Once the disclosure is complete (see date on Disclosure Screen), and you decide to have a legal firm perform a search, this screen tracks the process. It keeps track of which firm(s) you use, the attorney assigned to the search, and the dates associated with tracking the process. And, as with other modules, it gives you six additional user-defined fields and a free text comment field. Keep in mind that all information collected can be retrieved through the Query/Report module.

PATENT APPLICATIONS - Organizing applications and insuring that all comply with government regulations by specific dates is made simple through this screen. Coupled with the Status Lists (office reminders) and the Query/Report module, Technology Transfer can become your complete in-house "tickler system"; no more missed dates or last minute scrambles to meet deadlines!

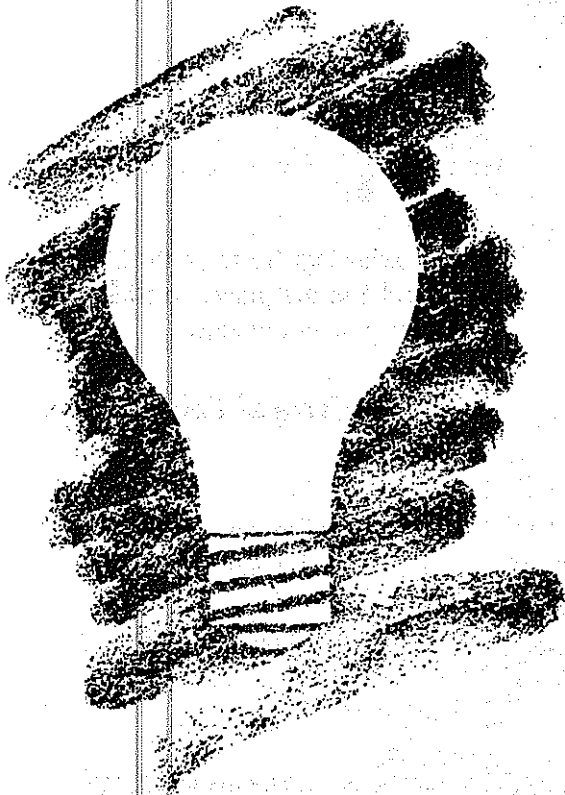
