Dear Howard:

Five years ago your participation helped make our Technology Transfer Conference here in Cleveland a very meaningful and worthwhile experience for those who attended. (An additional 500 copies of the published Proceedings have since been distributed.) As you know, while quite a few problems were brought into focus and discussed, many are still with us. My reason for writing to you at this time is to solicit your opinion and advice about those problems involving the status of the university's relationship with industry.

It is my impression that a substantial gulf separates the industrial and university communities. Having worked in each for approximately the same number of years, I am keenly aware of the insularity and lack of understanding existing in both camps. While my experience tends to discourage any optimism that the gap can be easily closed, I am wondering if some useful efforts could be made to narrow it and thus improve the university/industry interface.

I am running up the flagpole an idea for a proposed national meeting labeled "Improving the University/Industry Interface". The major objective would be to explore specific means for facilitating communication and understanding and thus to catalyze a more effective working relationship between these two important communities. Such a meeting would be open to industrialists (e.g. Directors of Research, corporate attorneys and others), university administrators, as well as faculty members. Program participants could be drawn from both general categories. Specific topics and appropriate speakers would be selected and arranged by a planning and program committee. A report of the proceedings could be published as was done for our Cleveland meeting.

Is it a worthwhile idea? Would you favor and support it? I would appreciate having your frank opinion and your advice. If a sufficient number of people offer encouragement I would be willing to take the initiative to get the ball rolling. On the other hand, if there is little enthusiasm I'll let it rest. Please write to me at your convenience.
