Dear Mr. Ayres:

Reference is made to my letter of November 10, 1953, establishing administrative procedures to carry out the signed agreement between the Public Health Service and Iowa State College which provides that the ownership and disposition of all domestic rights in inventions arising under Public Health Service grants and awards shall be left for administration by the College.

The purpose of this letter is to enlist your aid in fulfilling the terms of this agreement. Specifically, applications for research grants are being submitted from your institution with item (h) on the face sheet unchanged. We have not returned these applications to you because most of them are received during the rush of meeting deadlines and processing for study section and council review. We have therefore stricken item (h) and substituted the correct statement on the copies in our official files.

Since it is necessary to continue using the present application for research grants for some months, we are requesting that you advise the appropriate people in your institution of the agreement between the Public Health Service and Iowa State College, so that applications submitted in the future will reflect the proper statement with respect to patent protection. Until such time as the new application blanks are received by your institution, it will be satisfactory if item (h) on the face sheet is stricken and the following statement typed in below:

"Item h governed by terms of September 14, 1953
Letter of agreement on patent protection."

I should like to take this opportunity to remind you of the annual report due from Iowa State College on June 30 of each year. Since we have not heard from you in this connection, I would appreciate a statement at this time.

Your assistance in this matter will be very much appreciated.
