Otto Festge has told me of your August 2 telephone call regarding H.R. 2414, the University Small-Business Patent Policy Act.

I had planned to schedule hearings earlier this year on H.R. 2414; however, when I was informed that the Administration refused to testify before the Senate Criminal Justice Subcommittee when requested to do so by Senator Bayh, I decided to delay a scheduling decision for my own subcommittee. As you may know the President presently has before him a number of patent policy options recommended by the task force on industrial innovation. Since the President's decision may seriously effect H.R. 2414, I have delayed a decision on processing the legislation until we have heard from the Administration.
