Tom Martin of the University of Utah has sent the following information regarding the 4,000,000th patent which will issue in the latter part of this year. In a visit to Tom, Mr. Dann, Commissioner of Patents, indicated that he would give strong consideration to the selection of a university owned patent as Patent No. 4,000,000.

As Tom points out, Patent No. 3,000,000 was issued to a corporation. Emphasis may now well be on the "lone inventor" working in his laboratory.

Tom indicates that the following considerations should be met by the patent application:

- 1) It must be allowed now and acceptable for payment of final fee;
- 2) it should be processed and/or owned by a university;
- 3) it would be a plus feature if the invention were the result of a federal grant with or without further financial backing of a corporation
- 4) another plus factor would be that the invention is to benefit the public by commercial introduction in the near future.

Tom urges all universities who have eligible patent applications to submit their inventions, setting forth all possible conditions as outlined above, plus any others which may come to mind. All entries should be directed to:

NASA PATENT WAIVER CONDITION

T. L. Stam at the California Institute of Technology reports that NASA is willing to grant a petition for a waiver on the condition:

"California Institute of Technology and/or its assigns allocate and use 25% of its royalty income in excess of \$100,000 that is derived from the waived invention in furtherance of the transfer of aerospacerelated technology in accordance with an established Caltech-JPL program."
