Minutes of Trustees' Meeting

June 26, 1978

The meeting was called to order by President Howard Bremer at 9:30 a.m. at the O'Hare/Hilton in Chicago, Illinois.

The results of the Questionnaire mailed out to all members on April 19, 1978 showed that the majority of members preferred one meeting per year in conjunction with the Dvorkovitz Technology Fair to be held in Atlanta, GA on 2/27/79. The SUPA meeting will be held on Monday, February 26, 1979 with a Trustees' Meeting on Sunday, February 25, 1979 in the evening. The meeting will be held at the OMNI Hotel. The votes were evenly divided as to affiliation with another organization, consequently another vote will be taken at a future date.

Suggestion was made to set up a representative booth at meetings of other organizations (NCURA, SRA, etc.) to let it be known that we can act as a lobbying group when legislation affects University business by mass letter writing.

A motion was made, seconded and passed that SUPA members who retire from their positions (not to accept other positions or promotions) would be voted a "Member Emeritus" with voting power but no dues. The Charter Committee was commissioned to write this into the by-laws and present at next annual meeting.

The original 9 SUPA members paying an initial fee of \$100, after receiving credit for said fee, will pay annual dues starting January, 1979. The "Charter" Members who have been paying their dues will also receive a credit for dues paid.

A motion was made, seconded and passed that the SUPA funds be transferred out of the Florida bank into a local bank. The treasurer is commissioned to look into appropriate investment accounts from which funds can be easily transferred to a checking account when needed, and make recommendations to President.
