#### Re: Magnavox v. Activision

Gentlemen:

This will confirm our agreement in principle to settle the pending lawsuit, Magnavox Company and Sanders Associates, Inc. v. Activision Inc., Civil Action No. C82-5270, on the following terms:

 Activision will acknowledge the validity and infringement and/or contributory infringement of the patent in suit, Re. 28,507 to Rusch.

2) Magnavox will grant to Activision a release from past infringement and/or contributory infringement of the Sanders' patents exclusively licensed to Magnavox, by home video game cartridges sold by Activision prior to January 1, 1985. In consideration of said release, Activision will pay to Magnavox the sum of \$1,150,000 in the following installments:

\$400,000	April 1, 1985
\$200,000	October 1, 1985
\$275,000	April 1, 1986
\$275,000	April 1, 1987

The \$400,000 and \$200,000 payments due April 1, 1985 and October 1, 1985, respectively, shall be guaranteed by letter of credit. Activision, Inc. February 12, 1985 Page -2-

> 3) Magnavox will grant to Activision a running royalty license under the Sanders patents exclusively licensed to Magnavox under which Activision shall pay the following royalty for each home video game cartridge covered by any of said Sanders patents:

a) 4-1/2% of the Net Selling Price, if the Net Selling Price is over \$10 per cartridge;

b) 2-1/4% of the Net Selling Price, if the Net Selling Price is \$5-\$10 per cartridge; and

c) 1% of the Net Selling Price, if the Net Selling Price is less than \$5 per cartridge.

4) Magnavox will grant to Activision a paid-up license for home computer game software under the Sanders patents exclusively licensed to Magnavox for payment by Activision of the sum of \$200,000, which payment shall be contingent on either of the reissue applications of Baer Serial Numbers 810,538 and 810,542 issuing as a reissue patent with a claim similar to any one of claims 1, 13, 25, 40, 50, 53 to 56, 59, 83 or 91 now pending in application Serial No. 810,538 or any one of claims 1, 3, 7, 9, 12, 26 to 29, or 31 now pending in application Serial No. 810,542. In the event of issuance of said reissue patent to Baer with said claim, then said sum of \$200,000 shall be paid by Activision in the following installments:

\$100,000	within two months of issuance of said Baer reissue patent or April 1, 1987, whichever is later,
\$100,000	one year after payment of the initial \$100,000

5) This agreement in principle shall not be binding until a definitive agreement is executed by the parties.
