To confirm some of our previous conversations, the Activision case has been reassigned to Judge John P. Vukasin, Jr. of the District Court in San Francisco. Judge Vukasin was sworn in as a District Court Judge on November 15th of this year, but has had prior experience as a State Court Judge. Copies of two press clippings and a page with biographical information on Judge Vukasin are enclosed herewith for your information.

Judge Vukasin requested that counsel for the parties appear at a status hearing on last Tuesday, November 22. Judge Vukasin set May 31, 1984 as the discovery cut-off date, September 27, 1984 at 10:00 A.M. for a pre-trial conference, and October 8, 1984 for trial. We informed the Judge that the trial was expected to take approximately two weeks or ten trial days.

Judge John Vukasin to be Sworn in Today

Judge John P. Vukasin Jr. will be sworn in today as U.S. District Judge for the Northern District of California.

First appointed to the bench in Alameda County Superior Court by former Gov. Ronald Reagan in 1974, Vukasin was appointed by the president to the federal court Sept. 20.

Vukasin will fill a vacancy created last fall when U.S. District Court Judge Stanley A. Weigel became a senior judge.

Presiding over the 4 p.m. induction in the Ceremonial Courtroom of the Federal Building, U.S. District Court Chief Judge Robert F. Peckham will administer the oath of office as the other members of the court sit *en banc*.

Guest speakers include 9th Circuit U.S. Court of Appeals Chief Judge James R. Browning; Oakland Mayor Lionel Wilson; and Alameda County Superior Court Senior Judge Robert

H. Kroninger.

Other guest speakers are John A. Sutro Sr., senior partner in the San Francisco firm Pillsbury, Madison & Sutro; Lincoln Mintz, senior partner in the Oakland firm Mintz, Giller, Himmelman & Mintz; Robert Cartwright, senior partner in the San Francisco firm Cartwright, Sucherman, Slobodin & Fowler; Robert V. Dalenberg, vice president and general counsel, Pacific Telephone & Telegraph Co.; and Justin Roach, senior partner in the Oakland firm Crosby, Heafey, Roach & May.

A 1956 graduate of the University of California at Berkeley Law School — Boalt Hall, Vukasin was in private practice until 1969 when he was appointed commissioner of the California Public Utilities Commission by former Gov. Reagan.

He served as chairman of the state PUC from 1970 to 1972 and as president of the Western Conference of Public Service Commissions from 1971-1972.

Vukasin was chairman of the American Bar Association's Section of Public Utility Law in 1981-82 and a member of that group's governing council from 1970 to 1973.

His articles on anti-merger laws and the value of the grand jury have been published in the Antitrust Bulletin and the Journal of the State Bar of California, respectively.

'Stockholm Syndrome'

Facing 'Involuntary Alliance' Issue

DETROIT — A judge hearing a kidnapping-sexual abuse case will be asked to decide if there is a point at which a victim enters an involuntary alliance with the captor for survival, as some psychiatrists claim.

The trial starting today before Recorder's Court Judge M. John Shamo will test a psychological phenomenon first brought into focus 10 years ago when Erik Olsson's hostages were freed from Stockholm's Swedish Kreditbanken vault after a six-day ordeal. The phenomenon is called the

In June, the woman allegedly endured three days of sexual abuse interwoven with satanic chants and Christian prayers, and told police she hugged one of her accused tormentors as she was being released.

Assistant Prosecutor Joseph Koch will try to prove the victim is a "sister in stress" with one of Olsson's victims, Kristin Enmark. Olsson had threatened to shoot her unless he was set free. On her release, she smiled at him and said "We'll see each other again."

Koch will call Dr. Harley Stock of

Defense attorneys John Goldpaugh and Charles Campbell say the woman's conduct shows she was a willing participant who later made up a bizarre tale to explain her absence from her family.

They have asked Shamo to bar Stock's testimony, saying the syndrome is not based on scientific facts.

Suits Over Wrongful D

Reagan may elevate controversial judge

What Richard Nixon couldn't do 10 years ago and Gov. Ronald Reagan couldn't do eight years ago, President Reagan is attempting to do now:

Appoint John P. Vukasin to a high judgeship.

The Examiner has learned the current Alameda County Superior Court Judge is the man Sen. S.I. Hayakawa and the Reagan administration want to fill the \$70,300-a-year lifetime position on the U.S. District Court in San Francisco. Judge Stanley Weigel's semi-retirement has created the opening.

Vukasin, 54, was proposed for the same position in April 1972 by Nixon, who wanted to elevate U.S. District Court Judge Samuel Conti to the Ninth Circuit Court of Appeals. The State Commission on Judicial Appointments was besieged by opponents of that plan. They took issue with Conti and with the reputation Vukasin built as a chairman of the Public Utilities Commission from 1970 to 1971.

Nixon gave up and let Reagan have a go at it two years later when the then-governor nominated Vukasin for the First District Court of Appeal in San Francisco. At an unusual public hearing before the judiciary appointments committee, people spoke for and against Vukasin.

One of the most effective speakers against the appointment was Seth M. Hufstедler, then president of the California Bar Association. Representing the group, he said that Vukasin did not have the trial experience necessary for an appeals court judge, and that the appellate appointment should not be

"another man on the street."

Another opponent of the nomination was William Bennett, who served on the PUC with Vukasin.

"Besides his lack of experience, he was opposed because there was a belief that he wasn't a fair man," said Bennett, who is now the chairman of the State Board of Equalization. "He was just outrageous in the way he conducted the (PUC) hearings. The state supreme court reversed three of his decisions on Southern Pacific. He was a typical conservative, if not reactionary Republican. I just hope he's learned something from being on the bench in Alameda County."

Citing "unwarranted controversy," Reagan withdrew Vukasin's name in 1974, something that hadn't happened to an appellate nominee since 1942.

Four months later, Reagan appointed Vukasin to the Alameda County Superior Court bench, a move that did not require any state approval.

Long an active Republican, Vukasin

was the Northern California director of Barry Goldwater's campaign for president and the Alameda County chapter chairman for Nixon's 1960 attempt at the presidency.

When a local newspaper endorsed Lyndon Johnson instead of Goldwater, Vukasin issued a statement calling the endorsement "an endorsement of street riots, of smut, the fast buck and of 90 mile-an-hour beer-drinking limousine drivers."

Vukasin graduated from UC-Berkeley, took his law degree from Boalt Hall and served as a trial attorney for the state Division of Highways before entering private practice in 1958.

His appointment to the PUC in January 1969 was the fourth by Reagan to the five-member board. During his two-year presidency of the PUC, Vukasin came under fire several times for a variety of actions, including the closing of board sessions to the public and PUC staffers and an attempt to

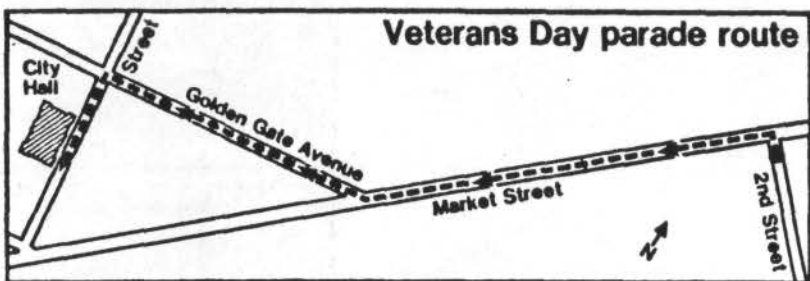
