This is a patent infringement suit. Plaintiff, EWI Holdings, Inc. ("EWI") has asserted claims 1-5, 10-11, 13-17, and 20-26 of U.S. Patent 6,526,130 ("the '130 Patent") in this case against Defendant, PRE Solutions, Inc. ("PRE") (collectively, "the Parties").
