ORDER

CLARENCE COOPER, District Judge.

Upon review and consideration of Defendant UTStarcom, Inc.'s Motion to Adopt In-Part the Special Master's Report and Recommendations Regarding Claim Construction [Doc. No. 192] and Plaintiff Datascape, Inc.'s consent/lack of opposition thereto, the Court hereby **ORDERS** that the Special Master's Report and Recommendation Regarding Claim Construction for the following claim terms/phrases are **ADOPTED**:

- (1) open network;
- (2) extended open network protocol;
- (3) extended network protocol;
- (4) extended open network protocol statement(s);
- (5) extended open network statements;
- (6) extended Internet protocol statements;

- (7) extended hypertext transfer protocol (HTTP) statements;
- (8) extended hypertext markup language (HTML) command statements;
- (9) web server;
- (10) operation;
- (11) screen phone;
- (12) hot key;
- (13) communicate;
- (14) form;
- (15) automatically;
- (16) extended Internet protocol;
- (17) communicatively coupled;
- (18) Internet;
- (19) identify/identifying/identified;
- (20) smart card reader; and
- (21) smart card.

The Court **FURTHER ORDERS** that Defendant UTStarcom, Inc.'s Motion for Permission to File a Reply to Datascape's Response to Defendants' Objections to Special Master's Reports and Final Recommendations [Doc. No. 204] is **GRANTED**. UTStarcom shall have until September 5, 2008, to file a reply to the documents filed in this action at Docket Numbers 199 and 200.
