#### HOUSE OF REPRESENTATIVES.

Under the changed conditions in human events the call is imperative and will tax the ingenuity and statesmanship of its Members. Great are the problems confronting it. Questions of moment wait upon it for solution. Hence we pray for Thy wisdom to guide it, Thy strength to sustain it, Thy courage to inspire it to deliberate yet speedy action.

Let Thy blessing descend upon the Speaker of this House and the Representatives of the people that he may guide with a firm and strong hand its Members to the highest and best solution of the great questions at home and abroad; that its acts may be to the best interests of all concerned and redound to the glory of the living God, our Heavenly Father.

Since the Sixty-fifth Congress passed into history two of its Members who had been elected to serve in this Congress have been called to the larger life. Their work well done, strong friendships formed, their going brings sadness to many hearts. We pray for those who knew and loved them, especially their respective families, that they may be comforted by the eternal hope of the immortality of the soul. This we ask in the name of Him who died and rose again. Amen.

PROCLAMATION OF THE PRESIDENT.

BY THE PRESIDENT OF THE UNITED STATES OF AMERICA-A PROCLAMATION. Whereas public interests require that the Congress of the United States should be convened in extra session at 12 o'clock noon on the 19th day of May, 1919, to receive such communication as may be made by the Executive: Now, therefore,

I, Woodrow Wilson, President of the United States of America, do hereby proclaim and declare that an extraordinary occasion requires the Congress of the United States to convene in extra session at the Capitol, in the District of Columbia, on the 19th day of May, 1919, at 12 o'clock noon, of which all persons who shall at that time be entitled to act as Members thereof are hereby required to take notice.

Given under my hand and the seal of the United States of America the 7th day of May, in the year of our Lord 1919 and of the independence of the United States the one hundred and forty-third.

#### MESSAGE FROM THE HOUSE.

#### WOMAN SUFFRAGE.

Mr. JOHNSON of California. Mr. President, I ask, in accordance with subdivision 3 of Rule XIV, that the joint resolution just received from the House of Representatives may be

read twice and then be placed upon the calendar.

Mr. UNDERWOOD. Mr. President, I understand it requires unanimous consent to have the joint resolution considered without going to the committee. I will say that I have no desire to

unduly delay the consideration of the joint resolution at the proper time. It is a well-known fact that I am opposed to it, and I expect to vote against it. It should be considered in an orderly and proper way, and I shall certainly object to its consideration until it has been referred to a committee and properly considered.

Mr. JOHNSON of California. It is that it may be considered in an orderly and proper way that the motion is made, and it is made in conformity with subdivision 3, Rule XIV. The desire is not at all to press the matter with any undue haste, but that, in accordance with the rule, the joint resolution may be read twice and then be placed upon the calendar and ultimately may be taken up on motion.

Mr. UNDERWOOD. As I understand it——
The VICE PRESIDENT. This is the rule, of course. Without objection, unless the Senate otherwise orders, the first and second reading of a bill may be by title only; and there having been no objection, it will be read the first and second times by

title and will go to the Committee on Woman Suffrage.

The joint resolution (H. J. Res. 1) proposing an amendment to the Constitution of the United States extending the right of

suffrage to women was read twice by its title.

Mr. JONES of Washington. Mr. President, it seems to me that the Senate has it within its power by order to direct that it shall go to the calendar instead of to the committee, if the question of reference is raised. That, I understand, the Senator from California raises. The rule does not say that it shall go to the committee automatically, but unless otherwise ordered it goes to the committee.

The VICE PRESIDENT. There has to be unanimous consent.

Mr. JONES of Washington. It can not go to the committee without unanimous consent.

The VICE PRESIDENT. The Chair has ruled a number of times, and the precedents of the Senate are unvarying upon the proposition, that unless there is unanimous consent a bill or resolution has to go to a committee.

Mr. JONES of Washington. I ask unanimous consent that the joint resolution may go to the calendar, not to be taken up

for consideration to-day, but that it go to the calendar.

Mr. UNDERWOOD. I think I made it clear a moment ago that I am not willing to consent that the joint resolution shall be taken up in the Senate until it has been carefully and fully and deliberately considered by the appropriate committee. Therefore, of course, I object.

The VICE PRESIDENT. The joint resolution goes to the

Committee on Woman Suffrage.

#### URGENT DEFICIENCY APPROPRIATIONS.

Mr. LODGE. I ask that the bill received from the House be laid before the Senate.

The bill (H. R. 2329) making appropriations to supply deficiencies in appropriations for the Bureau of War Risk Insurance and for the payment of pensions for the fiscal year ending June 30, 1919, was read twice by its title.

Mr. Fletcher introduced the following bill; which was read twice and referred to the Committee on Patents.

#### A BILL

To give effect to certain provisions of the Convention for the Protection of Trade-Marks and Commercial Names, made and signed in the City of Buenos Aires, in the Argentine Republic, August 20, 1910, and for other purposes.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the Commissioner Patents shall keep a register of all marks communicated to him by the international bureaus provided for by the Convention for the Protection of Trade-Marks and Commercial Names, made and signed in the city of Buenos Aires, in the Argentine Republic, August 20, 1910, in connection with which the fee of \$50 gold for the international registration established by article 2 of that convention has been paid, which register shall show a facsimile of the mark; the name and residence of the registrant; the number, date, and place of the first registration of the mark, including the date on which application for such registration was filed and the term of such registration, a list of goods to which the mark is applied

as shown by the registration in the country of origin, and such other data as may be useful concerning the mark.

- SEC. 2. That whenever any person shall deem himself injured by the inclusion of a trade-mark on this register, he may at any time apply to the Commissioner of Patents to cancel the registration thereof. The commissioner shall refer such application to the examiner in charge of interferences, who is empowered to hear and determine this question, and who shall give notice thereof to the registrant. If it appears after a hearing before the examiner that the registrant was not entitled to the exclusive use of the mark at or since the date of his application for registration thereof, or that the mark is not used by the registrants, or has been abandoned, and the examiner shall so decide, the commissioner shall cancel the registration. Appeal may be taken to the commissioner in person from the decision of the examiner in charge of interferences.
- SEC. 3. That any person who shall willfully and with intent to deceive, affix, apply, or annex, or use in connection with any article or articles of merchandise, or any container or containers of the same, a false designation of origin, including words or other symbols, tending to falsely identify the origin of the merchandise, and shall then cause such merchandise to enter into interstate or foreign commerce, and any person who shall knowingly transport such merchandise or cause or procure the same to be transported in interstate or foreign commerce or commerce with Indian tribes, or shall knowingly deliver the same to any carrier to be so transported, shall be liable to an action at law for damages and to an action in equity for an injunction, at the suit of any person, firm, or corporation doing business in the locality falsely indicated as that of origin, or in the region in which said locality is situated, or at the suit of any association of such persons, firms, or corporations.
- SEC. 4. Any person who shall without the consent of the owner thereof reproduce, counterfeit, copy, or colorably imitate any trade-mark on the register provided by this act, and shall affix the same to merchandise of substantially the same descriptive properties as those set forth in the registration, or to labels, signs, prints, packages, wrappers, or receptacles intended to be used upon or in connection with the sale of merchandise of substantially the same descriptive properties as those set forth in such registration, and shall use, or shall have used, such reproduction, counterfeit, copy, or colorable imitation in commerce among the several States, or with a foreign nation, or with the Indian tribes, shall be liable to an action for damages therefor at the suit of the owner thereof; and whenever in any such action a verdict is rendered for the plaintiff, the court may enter judgment therein for any sum above the amount found by the verdict as the actual damages, according to the circumstances of the case, not exceeding three times the amount of such verdict, together with the costs.
- SEC. 5. That it shall be the duty of a registrant under this act to comply with the law of the country in which his original registration took place, in respect to giving notice to the public that the trade-mark is registered, in connection with the use of such trade-mark in the United States of America, and in any suit for infringement by a party failing to do this, no damages shall be recovered, except on proof that the defendant was duly notified of the infringement and continued the same after such notice.
- SEC. 6. That the provisions of sections 15, 17, 18, 19, 20, 21, 22, 23, 25, 26, 27, and 29 of the act approved February 20, 1905, entitled "An act to authorize the registration of trade-marks used in commerce with foreign nations or among the

several States, or with Indian tribes, and to protect the same," \* as amended to date, are hereby made applicable to marks placed on the register provided for by section 1 of this act.

Sec. 7. That written or printed copies of any records, books, papers, or drawings belonging to the Patent Office and relating to trade-marks placed on the register provided for by this act, when authenticated by the seal of the Patent Office and certified by the Commissioner thereof, shall be evidence in all cases wherein the originals could be evidence, and any person making application therefor and paying the fee required by law shall have certified copies thereof.

SEC. 8. That the same fees shall be required for certified and uncertified copies of papers and for records, transfers, and other papers, under this act, as are required by law for such copies of patents and for recording assignments and other papers relating to patents.

On filing an appeal to the Commissioner of Patents from the decision of the examiner in charge of interferences, awarding ownership of a trade-mark, cancelling or refusing to cancel the registration of a trade-mark, a fee of \$15 shall be payable.

A bill similar to the foregoing, H. R. 266, is pending in the House of Representatives.

Such Popyright shall be secured by printing or publishing upon each copy of such document or work issued or published the words "United States Government, copyright reserved." Such copyright may thereafter be released by publishing upon any copy of such work or document issued or published the words "United States Government, copyright released."
