AN ACT

To authorize the registration of trade-marks used in commerce with foreign nations or among the several States or with Indian tribes, and to protect the same.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That the owner of a trade-mark used in commerce with foreign
- 4 nations, or among the several States, or with Indian tribes,
- 5 provided such owner shall be domiciled within the territory
- 6 of the United States, or resides in or is located in any foreign
- 7 country which, by treaty, convention, or law, affords similar
- 8 privileges to the citizens of the United States, may obtain
- 9 registration for such trade-mark by complying with the follow-
- 10 ing requirements: First, by filing in the Patent Office an ap-
- 11 plication therefor, in writing, addressed to the Commissioner of
- 12 Patents, signed by the applicant, specifying his name, domicile,



location, and citizenship; the class of merchandise and the par-1 $\mathbf{2}$ ticular description of goods comprised in such class to which the 3 trade-mark is appropriated; a description of the trade-mark 4 itself, and a statement of the mode in which the same is applied and affixed to goods, and the length of time during which the $\mathbf{5}$ trade-mark has been used. With this statement shall be filed a 6 drawing of the trade-mark, signed by the applicant, or his 7 attorney, and such number of specimens of the trade-mark, 8

Patents. Second, by paying into the Treasury of the United States the sum of ten dollars, and otherwise complying with the requirements of this Act and such regulations as may be

prescribed by the Commissioner of Patents.

14 Sec. 2. That the application prescribed in the foregoing 15 section, in order to create any right whatever in favor of the party filing it, must be accompanied by a written declaration 16 verified by the applicant, or by a member of the firm or an offi-17 cer of the corporation or association applying, to the effect that 18 the applicant believes himself or the firm, corporation, or 19 association in whose behalf he makes the application to be the 20 owner of the trade-mark sought to be registered, and that 21no other person, firm, corporation, or association, to the 22 best of the applicant's knowledge and belief, has 23 right to such use, either in the identical form or in such 24 near resemblance thereto as might be calculated to deceive; 25

LEGISLATIVE INTENT SERVICE

- that such trade-mark is used in commerce among the sev-1
- eral States, or with foreign nations, or with Indian tribes, and 2
- that the description and faesimile drawing presented truly rep-3
- resent the trade-mark sought to be registered. If the appli-4
- cant resides or is located in a foreign country, the state-5
- ment required shall, in addition to the foregoing, set forth that 6
- the trade-mark has been registered by the applicant, or that 7
- an application for the registration thereof has been filed by 8
- him in the foreign country in which he resides or is located, 9
- and shall give the date of such registration, or the application 10
- therefor, as the case may be, except that in the application 11
- in such cases it shall not be necessary to state that the mark 12
- 13 has been used in commerce with the United States or among
- the States thereof. The verification required by this section 14
- may be made before any person within the United States 15
- authorized by law to administer oaths, or, when the applicant 16
- resides in a foreign country, before any minister, chargé 17
- d'affaires, consul, or commercial agent holding commission 18
- under the Government of the United States, or before any 19
- notary public, judge, or magistrate having an official seal 20
- and authorized to administer oaths in the foreign country in 21
- which the applicant may be whose authority shall be proved 22
- by a certificate of a diplomatic or consular officer of the 23
- 24United States.
- SEC. 3. That every applicant for registration of a trade-25



- mark, or for renewal of registration of a trade-mark, who is 2 not domiciled within the United States, shall, before the issu-3 ance of the certificate of registration, as hereinafter provided 4 for, designate, by a notice in writing, filed in the Patent Office, 5 some person residing within the United States on whom process or notice of proceedings affecting the right of ownership 6 of the trade-mark of which such applicant may claim to be 7 the owner, brought under the provisions of this Act or under 8 9 other laws of the United States may be served, with the 10 same force and effect as if served upon the applicant or reg-11 istrant in person. For the purposes of this Act it shall be 12 deemed sufficient to serve such notice upon such applicant, 13 registrant, or representative by leaving a copy of such process 14 or notice addressed to him at the last address of which the Commissioner of Patents has been notified. 15 SEC. 4. That an application for registration of a trade-16 mark filed in this country by any person who has previously 17 18 regularly filed in any foreign country which, by treaty, convention, or law, affords similar privileges to citizens of the 19 United States an application for registration of the same 20
- would be accorded to the same application if filed in this

trade-mark shall be accorded the same force and effect as

- 25 Provided, That such application is filed in this country

- certificate of registration shall not be issued for any mark for . 3

- cant located in a foreign country until such mark has been 5
- actually registered by the applicant in the country in which
- he is located.
- 8 SEC. 5. That no mark by which the goods of the owner
- of the mark may be distinguished from other goods of the 9
- same class shall be refused registration as a trade-mark on 10
- 11 account of the nature of such mark unless such mark—
- 12 (a) Consists of or comprises immoral or scandalous
- 13 matter:
- 14 (b) Consists of or comprises the flag or coat of arms or
- 15 other insignia of the United States, or any simulation thereof,
- or of any State or municipality, or of any foreign nation: 16
- Provided, That trade-marks which are identical with a reg-17
- istered or known trade-mark owned and in use by another, 18
- and appropriated to merchandise of the same descriptive prop-19
- erties, or which so nearly resemble a registered or known 20
- trade-mark owned and in use by another, and appropriated to 21
- merchandise of the same descriptive properties, as to be 22
- likely to cause confusion or mistake in the mind of 23
- the public, or to deceive purchasers, shall not be reg-24
- istered: Provided, That no mark which consists merely in 25



the name of an individual, firm, corporation, or association, 1 2 not written, printed, impressed, or woven in some particular 3 or distinctive manner or in association with a portrait of 4 the individual, or merely in words or devices which are descriptive of the goods with which they are used, or of 5 6 the character or quality of such goods, or merely a geograph-7 ical name or term, shall be registered under the terms of this 8 Act: Provided further, That no portrait of a living individ-9 ual may be registered as a trade-mark, except by the consent 10 of such individual, evidenced by an instrument in writing: 11 And provided further, That nothing herein shall prevent the 12 registration of any trade-mark mark used by the applicant or 13 his predecessors, or by those from whom title to the trademark mark is derived, in commerce with foreign nations or 14 15 among the several States, or with Indian tribes, which was in 16 actual and lawful use as a trade-mark of the applicant or his 17 predecessors from whom he derived title for ten years prior to the passage of this Act. 18 SEC. 6. That on the filing of an application for regis-19 tration of a trade-mark which complies with the requirements 20 of this Act, and the payment of the fees herein provided for, 21 22 the Commissioner of Patents shall cause an examination thereof to be made; and if on such examination it shall 23

appear that the applicant is entitled to have his trade-mark

registered under the provisions of this Act, the Commissioner

- 1 shall cause the mark to be published at least once in the
- 2 Official Gazette of the Patent Office. Any person who
- 3 believes he would be damaged by the registration of a mark
- 4 may oppose the same by filing notice of opposition, stating
- 5 the grounds therefor, in the Patent Office within thirty days
- 6 after the publication of the mark sought to be registered,
- 7 which said notice of opposition shall be verified by the per-
- 8 son filing the same before one of the officers mentioned in
- 9 section two of this Act. If no notice of opposition is filed
- 10 within said time the Commissioner shall issue a certificate of
- 11 registration therefor, as hereinafter provided for. If on ex-
- 12 amination an application is refused, the Commissioner shall
- 13 notify the applicant, giving him his reasons therefor.
- 14 Sec. 7. That in all cases where notice of opposition has
- 15 been filed the Commissioner of Patents shall notify the ap-
- 16 plicant thereof and the grounds therefor.
- Whenever application is made for the registration of a
- 18 trade-mark which is substantially identical with a trade-mark
- 19 appropriated to goods of the same descriptive properties, for
- 20 which a certificate of registration has been previously issued
- 21 to another, or for registration of which another has previously
- 22 made application, or which so nearly resembles such trade-
- 23 mark, or a known trade-mark owned and used by another,
- 24 as, in the opinion of the Commissioner, to be likely to be
- 25 mistaken therefor by the public, he may declare that an



- interference exists as to such trade-mark, and in every case of 1
- $\mathbf{2}$ interference or opposition to registration he shall direct the
- 3examiner in charge of interferences to determine the question
- 4of the right of registration to such trade-mark, and of the
- 5 sufficiency of objections to registration, in such manner and
- 6 upon such notice to those interested as the Commissioner may
- 7 by rules prescribe.
- 8 The Commissioner may refuse to register the mark
- 9 against the registration of which objection is filed, or may re-
- 10 fuse to register both of two interfering marks, or may register
- the mark, as a trade-mark, for the person first to adopt and 11
- use the mark, if otherwise entitled to register the same, un-12
- 13 less an appeal is taken, as hereinafter provided for, from his
- decision, by a party interested in the proceeding, within such 14
- time (not less than twenty days) as the Commissioner may 15
- prescribe. 16
- SEC. 8. That every applicant for the registration of a 17
- trade-mark, or for the renewal of the registration of a trade-18
- mark, which application is refused, or a party to an inter-19
- ference against whom a decision has been rendered, or a 20
- party who has filed a notice of opposition as to a trade-mark, 21
- may appeal from the decision of the examiner in charge of 22
- trade-marks, or the examiner in charge of interferences, as the 23
- case may be, to the Commissioner in person, having once 24
- paid the fee for such appeal. 25



SEC. 9. That if an applicant for registration of a trade-1 mark, or a party to an interference as to a trade-mark, or a $\mathbf{2}$ party who has filed opposition to the registration of a trade-3 mark, or party to an application for the cancellation of the 4 registration of a trade-mark, is dissatisfied with the decision 5 of the Commissioner of Patents, he may appeal to the court 6 of appeals of the District of Columbia, on complying with the 7 conditions required in case of an appeal from the decision of 8 9 the Commissioner by an applicant for patent, or a party to an 10 interference as to an invention, and the same rules of practice 11 and procedure shall govern in every stage of such proceedings, as far as the same may be applicable. 12 13 Sec. 10. That every registered trade-mark, and every mark for the registration of which application has been made, 14 together with the application for registration of the same, shall 15 16 be assignable in connection with the good will of the business in which the mark is used. Such assignment must be by an 17 instrument in writing and duly acknowledged according to the 18 laws of the country or State in which the same is executed; 19 any such assignment shall be void as against any subsequent 20 purchaser for a valuable consideration, without notice, unless 21 it is recorded in the Patent Office within three months from 22

- SEC. 11. That certificates of registration of trade-marks 1
- shall be issued in the name of the United States of America, 2
- 3under the seal of the Patent Office, and shall be signed by
- 4 the Commissioner of Patents, and a record thereof, together
- with printed copies of the drawing and statement of the 5
- applicant, shall be kept in books for that purpose. . The cer-6
- 7 tificate shall state the date on which the application for regis-
- 8 tration was received in the Patent Office. Certificates of
- 9 registration of trade-marks may be issued to the assignee of
- 10 the applicant, but the assignment must first be entered of
- 11 record in the Patent Office.
- 12 Written or printed copies of any records, books, papers,
- 13 or drawings relating to trade-marks belonging to the Patent
- 14 Office, and of certificates of registration, authenticated by the
- 15 seal of the Patent Office and certified by the Commissioner
- thereof, shall be evidence in all cases wherein the originals 16
- could be evidence; and any person making application there-17
- 18 for and paying the fee required by law shall have certified
- copies thereof. 19
- Sec. 12. That a certificate of registration shall remain 20
- in force for twenty years, except that in the case of trade-21
- 22 marks previously registered in a foreign country such certifi-
- 23 cates shall cease to be in force on the day on which the
- 24trade-mark ceases to be protected in such foreign country,
- 25 and shall in no case remain in force more than twenty years,

- SEC. 15. That sections forty-nine hundred and thirty-3

- payment of fees paid by mistake, are hereby made applicable 6
- to trade-mark fees. 7
- 8 SEC. 16. That the registration of a trade-mark under
- the provisions of this Act shall be prima facie evidence of 9
- Any person who shall, without the consent of 10 ownership.
- 11 the owner thereof, reproduce, counterfeit, copy, or colorably
- imitate any such trade-mark and affix the same to merchan-12
- dise of substantially the same descriptive properties as those 13
- set forth in the registration, or to labels, signs, prints, pack-14
- ages, wrappers, or receptacles intended to be used upon or in 15
- connection with the sale of merchandise of substantially the 16

8 all suits at law or in equity respecting trade-marks registered 9 in accordance with the provisions of this Act, arising under 10 the present Act, without regard to the amount in controversy.

Sec. 18. That writs of certiorari may be granted by the Supreme Court of the United States for the review of cases arising under this Act in the same manner as provided for patent cases by the Act creating the circuit court of appeals.

SEC. 19. That the several courts vested with jurisdiction of cases arising under the present Act shall have power to grant injunctions, according to the course and principles of equity, to prevent the violation of any right of the owner of a trade-mark registered under this Act, on such terms as the court may deem reasonable; and upon a decree being rendered in any such case for wrongful use of a trade-mark the complainant shall be entitled to recover, in addition to the profits to be accounted for by the defendant, the damages the complainant has sustained thereby, and the court shall assess the same or cause the same to be assessed under its direction.

That in any case involving the right to a trade-7 mark registered in accordance with the provisions of this Act, in which the verdict has been found for the plaintiff, or an injunction issued, the court may order that all labels, signs, 10 11 prints, packages, wrappers, or receptacles in the possession of the defendant, bearing the trade-mark of the plaintiff or com-12 13 plainant, or any reproduction, counterfeit, copy, or colorable imitation thereof, shall be delivered up and destroyed. 14 injunction that may be granted upon hearing, after notice to 15 the defendant, to prevent the violation of any right of the 16 owner of a trade-mark registered in accordance with the pro-17 visions of this Act, by any circuit court of the United States, 18 or by a judge thereof, may be served on the parties against 19 whom such injunction may be granted anywhere in the 20 United States where they may be found, and shall be opera-21tive, and may be enforced by proceedings to punish for con-22 tempt, or otherwise, by the court by which such injunction 23 was granted, or by any other circuit court, or judge thereof, 24



- SEC. 22. That whenever there are interfering registered 17
- trade-marks, any person interested in any one of them may 18
- have relief against the interfering registrant, and all persons 19
- interested under him, by suit in equity against the said reg-20
- istrant; and the court, on notice to adverse parties and other 21
- due proceedings had according to the course of equity, may 22
- adjudge and declare either of the registrations void in whole 23
- or in part according to the interest of the parties in the trade-24

- 3 Sec. 23. That nothing in this Act shall prevent, lessen,

- 8 Sec. 24. That all applications for registration pending
- 9 in the office of the Commissioner of Patents at the time of

- 12 tions, under its provisions, and the prosecution of such appli-
- 13 cations may be proceeded with under the provisions of this
- 14 Act.
- 15 Sec. 25. That any person who shall procure registra-
- 16 tion of a trade-mark, or entry thereof, in the office of the
- 17 Commissioner of Patents by a false or fraudulent declaration
- 18 or representation, oral or in writing, or by any false means,
- 19 shall be liable to pay any damages sustained in consequence
- 20 thereof to the injured party, to be recovered by an action on
- 21 the case.
- 22 Sec. 26. That the Commissioner of Patents is author-
- 23 ized to make rules and regulations, not inconsistent with law,
- 24 for the conduct of proceedings in reference to the registra-
- 25 tion of trade-marks provided for by this Act.



SEC. 27. That no article of imported merchandise which 1 2shall copy or simulate the name of any domestic manufacture, 3or manufacturer or trader, or of any manufacturer or trader 4 located in any foreign country which, by treaty, convention, or law affords similar privileges to citizens of the United 5 6 States, or which shall copy or simulate a trade-mark regis-7 tered in accordance with the provisions of this Act, or shall 8 bear a name or mark calculated to induce the public to believe that the article is manufactured in the United States, or that 9 it is manufactured in any foreign country or locality other 10 11 than the country or locality in which it is in fact manufactured, 12 shall be admitted to entry at any custom-house of the United 13 States; and, in order to aid the officers of the customs in 14 enforcing this prohibition, any domestic manufacturer or trader, 15 and any foreign manufacturer or trader, who is entitled under the provisions of a treaty, convention, declaration, or agree-16 ment between the United States and any foreign country to 17 the advantages afforded by law to citizens of the United States 18 in respect to trade-marks and commercial names, may require 19 his name and residence, and the name of the locality 20 in which his goods are manufactured, and a copy of the cer-21 tificate of registration of his trade-mark, issued in accordance 22with the provisions of this Act, to be recorded in books which **2**3 shall be kept for this purpose in the Department of the Treas-24



- ury, under such regulations as the Secretary of the Treasury 1
- shall prescribe, and may furnish to the Department facsimiles $\mathbf{2}$
- of his name, the name of the locality in which his goods 3
- are manufactured, or of his registered trade-mark; and 4

- SEC. 28. That it shall be the duty of the registrant to 8
- give notice to the public that a trade-mark is registered, 9

- Patent Office," or abbreviated thus, "Reg. U. S. Pat. Off.," 11
- or when, from the character or size of the trade-mark, or 12
- from its manner of attachment to the article to which it is 13
- 14 appropriated, this can not be done, then by affixing a label
- containing a like notice to the package or receptacle wherein 15
- the article or articles are inclosed; and in any suit for in-16
- fringement by a party failing so to give notice of registration 17
- no damages shall be recovered, except on proof that the 18
- defendant was duly notified of infringement, and continued 19
- the same after such notice. 20
- SEC. 29. That in construing this Act the following rules 21
- must be observed, except where the contrary intent is plainly 22
- apparent from the context thereof: The United States includes 23
- and embraces all territory which is under the jurisdiction and 24

- control of the United States. The word "States" includes 1
- and embraces the District of Columbia, the Territories of the $\mathbf{2}$
- United States, and such other territory as shall be under the 3
- 4 jurisdiction and control of the United States. The terms "per-
- son" and "owner," and any other word or term used to des-5
- 6 ignate the applicant or other entitled to a benefit or privilege
- or rendered liable under the provisions of this Act, include a 7
- 8 firm, corporation, or association as well as a natural person.
- The term "applicant" and "registrant" embrace the successors 9
- and assigns of such applicant or registrant. The term "trade-10
- 11 mark" includes any mark which is entitled to registration
- under the terms of this Act and whether registered or not 12
- 13 and a trade-mark shall be deemed to be "affixed" to an article
- 14 when it is placed in any manner in or upon either the article
- 15 itself or the receptacle or package or upon the envelope or
