INTERNATIONAL CONVENTIONS REGARDING INTELLECTUAL PROPERTY AND THEIR MEMBERSHIP

Note by the Secretariat

Revision

- 1. This is a revision of the document prepared by the secretariat in response to the request of the Negotiating Group at its meeting of 10 June 1987 to provide a document listing international conventions regarding intellectual property rights and their membership. The information provided, in Annexes I-III, has been updated to 1 June 1989 (except in respect of the Inter-American treaties for which the information remains valid as of 1 January 1986).
- 2. <u>Annex I</u> presents in tabular form membership of the Convention Establishing the World Intellectual Property Organization (1967, amended in 1979) and of the following treaties providing for substantive protection of intellectual property:

(a) <u>Industrial Property</u>:

- Paris Convention for the Protection of Industrial Property (WIPO) (1883, revised 1900, 1911, 1925, 1934, 1958 and 1967, and amended 1979);
