INTERROGATORIES OF DEFENDANT, BLONDER-TONGUE LABORATORIES, INC., TO

PLAINTIFF, UNIVERSITY OF ILLINOIS FOUNDATION AND TO THE UNIVERSITY OF ILLINOIS UNDER RULE 33

The following interrogatories are directed to the University of Illinois Foundation and to the University of Illinois; and some of the questions relate particularly to Quarterly Engineering Report No. 2 prepared under Air Force Research Contract No. AF33(616)-6079, covering work done during the period 1 December 1958 to 1 March 1959, dated 31 March 1959 and purportedly distributed under a cover letter dated 27 April 1959. Each interrogatory is to be

answered by the person who has the best knowledge of the facts or, alternatively, by several such persons, each answering those parts as to which he has the best knowledge. Was there a preliminary draft of Quarterly Report No. 2? If the answer to question 1 is yes, how many 2. preliminary drafts were prepared? With respect to each preliminary draft: 3. How many copies were made? a. Are copies still in existence? b. Will they be made available for copying C. by defendant? Did the draft include a section corresd. ponding with Section 2 of the printed report, entitled "Log-Periodic Antenna Structures"? If the answer to d is yes, did such e. Section include a description and sketch of the log-periodic antenna? If the entire draft is not available for f. copying, is the section on "Log-Periodic Antenna Structure" available?

By whom was the log-periodic antenna g. section of each draft prepared? By whom was the log-periodic antenna h. section of each draft reviewed? Was a copy of any draft of the report 4. a. containing a section on log-periodic antennas sent outside the University? If the answer to question 4a is yes, ο. which draft or drafts? When were such copies sent? C. Identify each recipient of such copy d. by name, title and address. When was the final text of the report com-5. pleted? How many copies, other than the master copy, 6. of the final text were made? Who read and approved the final text before 7. reproduction? What was done with each copy of the final text, 8. other than the copies reproduced for distribution? - 3

 (5) Representatives of organizations named in the distribution list for Quarterly Report No. 2?

- 15. If the answer to any part of question 14 is yes, answer the following questions for each body which has such a library:
 - a. Is a copy of reproduced Quarterly Engineering Report No. 2 (under the above identified contract) in the collection?
 - b. If the answer to 14a is yes, when was each such copy received?
 - final text of Quarterly Engineering Report
 No. 2 available in the library before the
 report was reproduced?
 - d. Were copies of the preliminary draft or the final text of Quarterly Engineering Report No. 2 available to the library on request before the report was reproduced?
- 16. With regard to the reproduced copies of Quarterly Report No. 2 (under the above identified contract):

- a. Were copies sent to all of the individuals and organizations identified on the distribution list?
- b. Were all the copies sent by United States mail?
- c. If the answer to question 16b is no, state what other means of distribution was used.
- d. Were all the copies of the report sent at the same time?
- e. If the answer to question 16d is no, state when and to whom copies were distributed.
- f. Was each copy of the report accompanied by the cover letter dated April 27, 1959?
- g. If the answer to question lof is no, what went with those copies of the report not accompanied by such letter?
